2	This Act may be cited as the "Make Every Small
3	Business Count Act of 2013".
4	SEC. 2. CREDIT FOR CERTAIN SUBCONTRACTORS.
5	(a) In General.—Section 8(d) of the Small Busi-
6	ness Act (15 U.S.C. 637(d)) is amended by adding at the
7	end the following:
8	"(16) Credit for Certain Subcon-
9	TRACTOR.—For purposes of determining whether or
10	not a prime contractor has attained the percentage
11	goals specified in paragraph (6)—
12	"(A) if the subcontracting goals pertain
13	only to a single contract with the executive
14	agency, the prime contractor shall receive credit
15	for small business concerns performing as first
16	tier subcontractors or subcontractors at any tier
17	pursuant to the subcontracting plans required
18	under paragraph (6)(D) in an amount equal to
19	the dollar value of work awarded to such small
20	business concerns; and
21	"(B) if the subcontracting goals pertain to
22	more than one contract with one or more execu-
23	tive agencies, or to one contract with more than
24	one executive agency, the prime contractor may
25	only count first tier subcontractors that are
26	small business concerns.".

2	TRACTING.—Section 3 of the Small Business Act (15
3	U.S.C. 632) is amended by adding at the end the fol-
4	lowing:
5	"(dd) Definitions Pertaining to Subcon-
6	TRACTING.—In this Act:
7	"(1) Subcontract.—The term 'subcontract'
8	means a legally binding agreement between a con-
9	tractor that is already under contract to another
10	party to perform work, and a third party, herein-
11	after referred to as the subcontractor, for the sub-
12	contractor to perform a part, or all, of the work that
13	the contractor has undertaken.
14	"(2) First tier subcontractor.—The term
15	'first tier subcontractor' means a subcontractor who
16	has a subcontract directly with the prime contractor.
17	"(3) At any tier.—The term 'at any tier'
18	means any subcontractor other than a subcontractor
19	who is a first tier subcontractor.".
20	SEC. 3. GAO STUDY.
21	Not later than 365 days after the date of enactment
22	of this Act, the Comptroller General of the United States
23	shall submit to the Committee on Small Business of the
24	House of Representatives and to the Committee on Small
25	Business and Entrepreneurship of the Senate a report
