

## AMENDMENT TO H.R. 2763 OFFERED BY MRS. MURPHY OF FLORIDA

At the end of the bill, add the following new section:

1	SEC. 7. PROCUREMENT CENTER REPRESENTATIVES AND
2	OTHER ACQUISITION PERSONNEL IN THE
3	SBIR AND STTR PROGRAMS.
4	(a) Definition of Senior Procurement Execu-
5	TIVE.—Section 9(e) of the Small Business Act (15 U.S.C.
6	638(e)) is amended—
7	(1) in paragraph (12)(B), by striking "and" at
8	the end;
9	(2) in paragraph (13)(B), by striking the period
10	at the end and inserting "; and"; and
11	(3) by adding at the end the following new
12	paragraph:
13	"(13) the term 'senior procurement executive'
14	means an official designated under section 1702(c)
15	of title 41, United States Code, as the senior pro-
16	curement executive of a Federal agency participating
17	in a SBIR or STTR program.".
18	(b) Inclusion of Senior Procurement Execu-
19	TIVES IN SBIR AND STTR.—

1	(1) In General.—Section 9(b) of the Small
2	Business Act (15 U.S.C. 638(b)) is amended—
3	(A) in paragraph (8), by striking "and" at
4	the end;
5	(B) in paragraph (9), by striking the pe-
6	riod at the end and inserting "; and; and
7	(C) by adding at the end the following new
8	paragraph:
9	"(10) to coordinate, where appropriate, with the
10	senior procurement executive of the relevant Federal
11	agency to assist small business concerns partici-
12	pating in a SBIR or STTR program with commer-
13	cializing research developed under such a program
14	before such small business concern is awarded a con-
15	tract from such Federal agency.".
16	(2) TECHNICAL AMENDMENT.—Section 9(b)(3)
17	of the Small Business Act (15 U.S.C. 638(b)(3)) is
18	amended by striking "and" at the end.
19	(c) Modifications Relating to Procurement
20	CENTER REPRESENTATIVES AND OTHER ACQUISITION
21	Personnel.—
22	(1) SBIR AMENDMENT.—Section 9(j) of the
23	Small Business Act (15 U.S.C. 638(j)) is amended
24	by adding at the end the following new paragraph:

1	"(4) Modifications relating to procure-
2	MENT CENTER REPRESENTATIVES.—Upon the en-
3	actment of this paragraph, the Administrator shall
4	modify the policy directives issued pursuant to this
5	subsection to require procurement center representa-
6	tives (as described in section 15(l)) to assist small
7	business concerns participating in the SBIR pro-
8	gram, particularly in Phase III. The procurement
9	center representatives shall coordinate with the ap-
10	propriate contracting officer and the appropriate Di-
11	rector of the Office of Small and Disadvantaged
12	Business Utilization established pursuant to section
13	15(k) for the agency letting the contract.".
14	(2) STTR AMENDMENT.—Section 9(p)(2) of
15	the Small Business Act (15 U.S.C. $638(p)(2)$ ) is
16	amended—
17	(A) in subparagraph (E)(ii), by striking
18	"and" at the end;
19	(B) in subparagraph (F), by striking the
20	period at the end and inserting "; and"; and
21	(C) by adding at the end the following new
22	subparagraph:
23	"(G) procedures to ensure that procure-
24	ment center representatives (as described in
25	section $15(l)$ —

1	"(i) assist small business concerns
2	participating in the STTR program, par-
3	ticularly in Phase III; and
4	"(ii) coordinate with the appropriate
5	contracting officer and the appropriate Di-
6	rector of the Office of Small and Disadvan-
7	taged Business Utilization established pur-
8	suant to section 15(k) for the Federal
9	agency letting the contract in providing the
10	assistance described in clause (i).".
11	(d) Amendment to Duties of Procurement
12	Center Representatives.—Section 15(l)(2) of the
13	Small Business Act (15 U.S.C. 644(l)(2)) is amended—
14	(1) in subparagraph (I), by striking "and" at
15	the end;
16	(2) by redesignating subparagraph (J) as sub-
17	paragraph (L); and
18	(3) by inserting after subparagraph (I) the fol-
19	lowing new subparagraphs:
20	"(J) assist small business concerns partici-
21	pating in a SBIR or STTR program under sec-
22	tion 9 with Phase III;
23	"(K) coordinate with the appropriate con-
24	tracting officer and the appropriate Director of
25	the Office of Small and Disadvantaged Busi-

1	ness Utilization established pursuant to sub-
2	section (k) for the agency letting the contract;
3	and".
4	(e) Amendment to the Duties of the Director
5	OF SMALL AND DISADVANTAGED BUSINESS UTILIZATION
6	FOR FEDERAL AGENCIES.—Section 15(k) of the Small
7	Business Act (15 U.S.C. 644(k)) is amended—
8	(1) in paragraph (19), by striking "and" at the
9	end;
10	(2) in paragraph (20), by striking the period at
11	the end and inserting a semicolon; and
12	(3) by adding at the end the following new
13	paragraphs:
14	"(21) shall assist small business concerns par-
15	ticipating in a SBIR or STTR program under sec-
16	tion 9 with researching applicable solicitations for
17	the award of a Federal contract (particularly with
18	the Federal agency that has a funding agreement
19	(as defined under section 9) with the concern) to
20	market the research developed by such concern
21	under such SBIR or STTR program; and
22	"(22) shall provide technical assistance to small
23	business concerns participating in a SBIR or STTR
24	program under section 9 to submit a bid for an
25	award of a Federal contract, including coordination

- 2 propriate senior procurement executive for the agen-
- 3 cy letting the contract.".
