- 1 Be it enacted by the Senate and House of Representa-

- 4 This Act may be cited as the "Commonsense Con-
- 5 struction Contracting Act of 2013".

1	SEC. 2. REVERSE AUCTIONS PROHIBITED FOR CONTRACTS
2	FOR DESIGN AND CONSTRUCTION SERVICES.
3	The Small Business Act (15 U.S.C. 631 et seq) is
4	amended—
5	(1) by redesignating section 47 as section 48;
6	and
7	(2) by inserting after section 46 the following:
8	"SEC. 47. REVERSE AUCTIONS PROHIBITED FOR CON-

11	"(a) In General.—In the case of any contract for
12	design and construction services, reverse auction methods
13	may not be used if the contract—
14	"(1) is suitable for award to a small business
15	concern; or

19	"(C) section 15(a);
20	"(D) section 15(j);
21	"(E) section 31; or

23	"(b) Definitions.—For purposes of this section—
24	"(1) The term 'reverse auction' means, with re-
25	spect to procurement by an agency, a real-time auc-
26	tion on the Internet between a group of offerors who

1	compete against each other by submitting bids for a
2	contract or task order with the ability to submit re-
3	vised bids throughout course of the auction, and the
4	award being made to the offeror who submits the
5	lowest bid.
6	"(2) The term 'design and construction serv-
7	ices' means—
8	"(A) site planning and landscape design;
9	"(B) architectural and interior design;
10	"(C) engineering system design;
11	"(D) performance of construction work for
12	facility, infrastructure, and environmental res-
13	toration projects;
14	"(E) delivery and supply of construction
15	materials to construction sites; and
16	"(F) construction, alteration, or repair, in-
17	cluding painting and decorating, of public build-
18	ings and public works.".
