- 4 This Act may be cited as the "Improving Opportuni-
- 5 ties for Service-Disabled Veteran-Owned Small Businesses

SMALL BUSINESS DEFINITION OF SMALL BUSINESS 2 CONCERN CONSOLIDATED. 3 Section 3(q) of the Small Business Act (15 U.S.C. 4 632(q)) is amended— 5 (1) in paragraph (2), to read as follows: 6 "(2) Small business concern owned and 7 CONTROLLED BY SERVICE-DISABLED VETERANS.-8 The term 'small business concern owned and con-9 trolled by service-disabled veterans' means a small 10 business concern— 11 "(A)(i) not less than 51 percent of which 12 is owned by one or more service-disabled vet-13 erans or, in the case of any publicly owned busi-14 ness, not less than 51 percent of the stock of 15 which is owned by one or more service-disabled 16 veterans; and "(ii) the management and daily business 17 18 operations of which are controlled by one or 19 more service-disabled veterans or, in the case of 20 a veteran with permanent and severe disability, 21 the spouse or permanent caregiver of such vet-22 eran; or 23 "(B) not less than 51 percent of which is 24 owned by one or more veterans with service-25 connected disabilities that are permanent and

1SEC. 4. SBA TO ASSUME CONTROL OF VERIFICATION OF2OWNERSHIP AND CONTROL STATUS OF AP-3PLICANTS FOR INCLUSION IN THE DATABASE4OF SMALL BUSINESSES OWNED AND CON-5TROLLED BY SERVICE DISABLED VETERANS6AND VETERANS.

7 The Small Business Act (15 U.S.C. 631 et seq.) is8 amended by adding at the end the following:

9 "SEC. 47. VETS FIRST PROGRAM.

10 "Not later than 180 days after the effective date of 11 this section, the Administrator shall enter into a memo-12 randum of understanding with the Secretary of Veterans 13 Affairs that transfer control and administration of the 14 program under subsections (e) through (g) of section 8127 15 of title 38, United States Code, to the Administrator, con-16 sistent with the following:

17 "(1) Not later than 270 days after completing 18 the memorandum of understanding, the Adminis-19 trator shall make rules to carry out the memo-20 randum. If the Administrator does not make such 21 rules by such date, the Administrator may not exer-22 cise the authority under section 7(a)(25)(A) until 23 such time as those rules are made.

24 "(2) The Administrator shall assume authority25 and responsibility for maintenance and operation of

the database and for verifications under the pro gram.

3 "(3) Any appeal by a small business concern, at
4 the time that verification is denied or a contract is
5 awarded, of any determination under the program
6 shall be heard by the Office of Hearings and Appeals of the Small Business Administration.

8 "(4) The Secretary shall, for a period of 6 9 years commencing on a date agreed to in the com-10 pleted the memorandum, reimburse to the Adminis-11 trator of the Small Business Administration any 12 costs incurred by the Administrator for actions un-13 dertaken pursuant to the memorandum from fees 14 collected by the Secretary of Veteran Affairs under 15 multiple-award schedule contracts. Any disputes be-16 tween the Secretary and the Administrator shall be 17 resolved by the Director of the Office of Manage-18 ment and Budget".

19 SEC. 5. MEMORANDUM OF UNDERSTANDING.

20 Section 8127(f) of title 38, United States Code, is21 amended by adding at the end the following:

"(7) Not later than 180 days after the effective
date of this paragraph, the Secretary shall enter into
a memorandum of understanding with the Adminis-

- 2 sistent with section 47 of the Small Business Act.".
